## Admission Requirements

Admission to the program is based on\*:

- university degree in law or an equivalent qualification
- adequate ability in the English language
- high level of motivation to participate in the program
- at least one year's practical professional experience

***The application process is held entirely online!***

\*Exceptions could apply for the requirement of ECTS point of students who do not have 180 ECTS credits, could take an entrance exam worth 30 ECTS point.

## Enrollment Status

The IHL program allows for the possibility of three degree types: the first being an **LL.M. program (90 ECTS)** which can be done in both a full time or part time fashion; a **Diploma program (60 ECTS)** which will follow the same courses for two-semester worth, but will be shorter without the need to complete a thesis and an internship; and the last would be **certificate program (30 ECTS)** which will allow for even more concise curriculum consisting of one semester worth of courses, but still with the ability to specialize in a specific area.

Courses consist of both **face-to-face** and **distance-learning** elements. Lectures and seminars which require personal attendance of the student take place at the European University Viadrina (in April to June in the summer semester, and October to December in the winter semester). Students are expected to prepare intensively for the lectures and seminars and carry out follow-up work through distance learning or library activity to



consolidate the materials covered during face-to-face teaching. The distance-learning elements are presented via an internet platform providing for an interactive study.
