### **§ 1 Scope of application (Additionally § 1 ASPO)**

<sup>1</sup>The terms of the universal study and examination regulations for Bachelor and consecutive Master courses of study (ASPO) at Europa-Universität Viadrina Frankfurt (Oder) from 27.01.2016 last revised by amendment articles from 02.11.2016, for the study program International Business Administration with the degree Bachelor of Science at the Faculty of Business Administration and Economics at Europa-Universität Viadrina Frankfurt (Oder), are added to and explicated as follows:

### **§ 2 Objective of studies (Additionally § 1 (2) sentence 2, no. 1 ASPO)**

(1) <sup>1</sup>The study program is designed to teach students scientific reasoning and responsible behavior and to contribute to their personal development. <sup>2</sup>At the end of their studies, students should have acquired specific knowledge displaying grasp of the international dimension of economic activity and its social implications and to be able to independently apply the scientific tools they have learned to practical problems. <sup>3</sup>Primary objective of the academic education at the Faculty of Business Administration and Economics is to learn appropriate methods, which allow the identification, formulation and scientific treatment of individual and collective economic problems. <sup>4</sup>A goal of the education is also the professional ability of the students. <sup>5</sup>The required practical qualifications for professional capability cannot and are not supposed to be imparted by the university.

(2) <sup>1</sup>In correspondence with the faculty structure, particularly its international orientation, there is a big emphasis on the international economic aspects throughout the education. <sup>2</sup>Therefore the program strives to ensure profound education on business administration and open economy in combination with acquiring foreign language competences in internationally oriented modules. <sup>3</sup>Special attention is being paid to multidisciplinary aspects of subject matter.

<sup>1</sup> The following text is a translation of the study-specific regulations for the study program International Business Administration (Bachelor). Only the German language versions of these regulations are valid for all official and legal purposes. The English language version is provided merely as a guide.

**§ 3**  
**Degree**  
*(Additionally § 1 (2) sentence 2 no. 2 i.c.w.  
§ 2 (1) ASPO)*

<sup>1</sup>Upon successful completion of the Bachelor studies, the student is awarded the academic degree "Bachelor of Science" (abbr. B.Sc.).

**§ 4**  
**Beginning of studies**  
*(Additionally § 1 (2) sentence 2 no. 5 ASPO)*

<sup>1</sup>Studies begin in the winter semester of each year. Enrollments in higher semesters remain unaffected.

**§ 5**  
**Recognition of periods of study, academic and examination achievements as well as recognition of extracurricular knowledge and skills**  
*(Additionally § 12 ASPO)*

(1) <sup>1</sup>The recognition of periods of study, academic and examination achievements as well as recognition of extracurricular knowledge and skills is regulated by § 12 ASPO.

(2) <sup>1</sup>The applicant has to present the necessary information about the achievement of which recognition is requested. <sup>2</sup>The recognition is a result of an examination of the documents provided by the applicant. <sup>3</sup>In the case of refusal by the responsible examination board for the achievement to be recognized in accordance with § 12 (1) sentence 1 ASPO, a recognition assessment will be carried out at the written request of the student to the responsible examination board, given that the student provides credible evidence of having acquired the relevant knowledge and skills elsewhere. <sup>4</sup>The recognition assessment is to be carried out by a university professor of the Faculty of Business Administration and Economics, who is authorized to carry out such an assessment and is appointed by the responsible examination board. <sup>5</sup>The form of this recognition assessment is to be determined by the examination board upon consultation with the abovementioned authorized professor in accordance with § 23 (5) sentence 1, (6) sentence 1 ASPO, taking into account the qualification objectives to be achieved for the module to be recognised and the selection of the forms of assessment, specified in § 7 (1) of these regulations, and of the respective scope of examination.

(3) <sup>1</sup>If the examination is passed with at least "sufficient" ("ausreichend") the achievement counts as recognized. <sup>2</sup>In the event of failure to pass the assessment the student concerned must be informed of the decision of the examination board to reject a recognition in accordance with § 12 (6) sentence 1 ASPO and the reasons must be given to him/her.

**§ 6**  
**Standard study period, structure of studies, forms of teaching, mobility window**  
*(Additionally § 1 (2) sentence 2 no. 6,  
§ 4 (2), § 5 (1) sentence 1, (2) sentence 2,  
§ 7 (1) and (2), § 8 ASPO)*

(1) <sup>1</sup>The standard period of study is six semesters. <sup>2</sup>The study program comprises of 180 ECTS-Credits (in the following: Credits).

(2) <sup>1</sup>Students are free to choose in what order they complete the course studies and examinations. <sup>2</sup>The specific information on the courses frequency and possible existing admission requirements of the modules listed in the module descriptions must be considered. <sup>3</sup>The non-binding study plans attached in Annexes 2 and 3 provide an example of a reasonable structuring of the studies.

(3) <sup>1</sup>The study program includes modules from the areas of business administration and economics, optional modules of interdisciplinary areas such as in cultural sciences and law, the teaching of key qualifications as well as the Bachelor thesis. <sup>2</sup>The study program content is structured as follows:

- Basic economic education (72 credits),
- Specialization (54 credits),
- Extracurricular and Interdisciplinary competencies (42 credits) and
- Bachelor thesis (12 credits).

<sup>3</sup>In the first three semesters, which serve orientation purposes, students are to complete the modules of basic economic education and to provide proof of their knowledge in the Foreign Language module (CEFR B1 level). <sup>4</sup>The second term of studies (4th-6th semesters) contributes to specialization of studies. <sup>5</sup>During the specialization period the students further establish their expertise; additional competencies are obtained in the area of extracurricular and interdisciplinary qualifications.

(4) The basic economic education contains 12 compulsory modules (teaching and examination language is English) each worth 6 credits:

- International Management
- Marketing
- Financial Accounting
- Management Accounting
- Finance & Investments/  
Finanzen & Investition
- BusinessTaxation/  
Unternehmensbesteuerung
- Production & Logistics
- Business Informatics
- Mathematics
- Statistics
- Microeconomics
- Macroeconomics/ Makroökonomie

(5) <sup>1</sup>Within the specialization seven compulsory elective module groups are offered:

- Accounting
- Banking & Finance
- Economics

- Information & Operations Management
- Marketing, Management & Entrepreneurship
- Quantitative Methods
- Taxation

<sup>2</sup>One to three compulsory elective module groups are to be selected from the range of compulsory elective module groups. <sup>3</sup>In each of the selected compulsory elective module groups, between three and six modules with 6 credits each must be successfully completed. <sup>4</sup>The module catalog (Appendix 1) specifies whether the modules of the compulsory elective module group must be selected (compulsory modules) or can be selected (compulsory elective modules). <sup>5</sup>In an elective area, further modules in economics, which are not attributable to a chosen focus, or non-business modules in the amount of up to 18 credits can be included. <sup>6</sup>Students are recommended to complete at least one examination with a seminar paper. <sup>7</sup>The Examination Committee may add further modules to the catalog of modules. <sup>8</sup>The additions will be announced by means of a notice or suitable electronic systems.

(6) <sup>1</sup>The extracurricular and interdisciplinary qualifications comprise the foreign language modules

- Foreign language (Council of Europe level A2) with 12 credits,
- foreign language (Council of Europe level B2) with 12 credits

the module

- Scientific work with 6 credits

and other soft skills and internships amounting to 12 credits. <sup>2</sup>Proof of the foreign language module (CEFR A2 level) should be provided by the end of the second semester, proof of the foreign language module (CEFR B2 level) should be provided by the end of the fifth semester. <sup>3</sup>English cannot be selected as a foreign language in none of the two modules. <sup>4</sup>For foreign students who have not proven their ability to study in German, German as a foreign language is obligatory in both modules. <sup>5</sup>The achievements recognized as extracurricular and interdisciplinary qualifications will be assessed as study achievements with "passed" or "failed" and will not be included in the calculation of the overall final grade according to § 26 ASPO. <sup>6</sup>A guideline for the implementation and recognition of internships shall be issued by the responsible examination board.

(7) <sup>1</sup>Forms of the offered courses are, in particular, lectures, exercises, tutorials, colloquiums, seminars, projects, excursions, workshops and project days, internships and language courses. <sup>2</sup>Events with coordination and variety aspects are shown separately.

(8) <sup>1</sup>The international orientation of the study program must be taken into account in the second part of the studies, usually in the fifth or sixth semester, when one semester with the minimum duration of three months must be completed in a

foreign university (study stay abroad). <sup>2</sup>A recognition of the study abroad in accordance with sentence 1 shall only be granted if at least 12 credits have been earned and proven during this study stay. <sup>3</sup>A study abroad in the sense of these study-specific regulations is a stay at an approved foreign university with the right to award doctorates. <sup>4</sup>As a matter of principle, the achievements to be recognized must not be delivered in the student's native language. <sup>5</sup>The proof in the module "Foreign Language (CEFR B2 level)" as referred to in paragraph 6 counts to have been provided if during the study abroad modules in this foreign language worth at least 18 credits are provided and proven. <sup>6</sup>The recognition of study and examination achievements from a foreign university comply with § 12 ASPO.

(9) <sup>1</sup>In justified exceptional cases the responsible examination board can exempt students, upon request, from pursuing the studies abroad referred to in paragraph 8, sentence 1. <sup>2</sup>Such a request shall be justified in particular

- In the case of students who take care of children and/or close relatives,
- In the case of students with disabilities and/or chronic illnesses,
- In the case of students who are not of German nationality and who have not obtained their university entrance qualification in Germany or at a German school abroad

<sup>3</sup>Students who do not complete a study abroad in accordance with paragraph 8, sentence 1, must successfully complete the module group "Economics" within their specialization phase as well as successfully complete modules of at least 18 credits in their specialization phase whose teaching language must not be German. <sup>4</sup>In addition these students are to complete an international internship of at least four weeks during their studies.

(10) <sup>1</sup>In addition to paragraph 8, the faculty offers students the opportunity to obtain a double degree abroad with selected partner universities. <sup>2</sup>In this case, students must spend at least two semesters at the partner university abroad. <sup>3</sup>Students must apply for a place within the framework of a double degree agreement at the department of Europa-Universität Viadrina Frankfurt (Oder) responsible for organizing and carrying out their studies abroad. <sup>4</sup>The study and examination achievements amounting to 60 credits to be provided under the respective double degree agreement are listed in the non-binding study plan in Annex 3 of this study-specific regulations and documented in the respective double degree agreements, which are announced to the students by a notice board or the relevant electronic systems. <sup>5</sup>The compulsory or compulsory elective character of the modules to be provided can be found in the module catalogue (Annex 1). <sup>6</sup>Paragraph 8 sentences 4 to 5 apply respectively. <sup>7</sup>The Examination Board decides on the recognition of these study and examination achievements made within the framework of a double degree agreement, in accordance with the regulations of the respective double degree agreement with the respective partner university,

provided that these have been met in the agreement. <sup>8</sup>Also note the following Appendices 1 and 3 to this order.

## **§ 7**

### **Forms of examination, organisation of examinations, admission to examinations (Additionally § 4 (2), § 10 (3) sentence 2, § 11, §§ 13 to 16, § 17 (3) ASPO)**

(1) <sup>1</sup>According to §4 (2) ASPO, the qualification goals, the teaching and examination forms, including credits as well as the type and scope, are specified in the module descriptions. <sup>2</sup>Examination achievements are provided in accordance with the respective module description as follows:

- 120-minute written examination,
- oral examination of approximately 25 minutes per student,
- one or more home assignments as addition to the examination achievement (e. g. seminar paper),
- written examination of 90 minutes and one or more home assignments as addition to the examination achievement, or
- oral examination of approximately 20 minutes per student and one or more home assignments as addition to the examination achievement.

(2) <sup>1</sup>The examination board responsible appoints the examiners as well as - for course-related oral examinations with the exception of the last possibility of a repetition of these - the assessors. <sup>2</sup>For the examiners of the Bachelor thesis precede the provisions of § 17 (3) ASPO. <sup>3</sup>The responsible examination board can, by decision, assign the responsibility for appointing examiners and assessors to the chairman and his or her representative.

(3) As a rule, the written exams and oral examinations for courses of the Faculty of Business Administration and Economics are combined in examination blocks at the end of the course or before the beginning of the next semester.

(4) <sup>1</sup>The responsible examination board shall determine the place and time for the written or oral examination and shall announce them by notice board or the relevant electronic systems. <sup>2</sup>It may assign this task to the respective examiner. <sup>3</sup>A necessary short notice change of examiner(s), date of examination or examination place for compelling reasons is permitted; it must be announced immediately in the manner described above. <sup>4</sup>It is up to the students to pay attention at the notices or publications in electronic form.

(5) <sup>1</sup>A specific registration period (beginning and end) is to be determined for each written exam and for each oral examination and shall be announced by the responsible examination board. <sup>2</sup>Paragraph 4, sentence 2 and sentence 4 shall apply accordingly. <sup>3</sup>The students must register for the written exams and oral examinations within the registration period in the form determined by the

examiner(s) and the Examination Office. <sup>4</sup>In principle, the registration shall be made by means of the relevant electronic systems, unless a written procedure is exceptionally carried out. <sup>5</sup>In the case of missing registration, participation in the relevant examination is impossible or the examination performance will not be evaluated.

(6) Only those who are enrolled at the Europa-Universität Viadrina Frankfurt (Oder) and have not lost their rights to take part in examinations in the corresponding module of a basic economic study course at a university in the Federal Republic of Germany may be admitted to the examinations in this course of study.

## **§ 8**

### **Bachelor thesis**

#### **(Additionally § 1 (2) sentence 2 no. 7, § 17 (7) sentence 3, (9) sentences 1 and 3, (11) sentence 3 ASPO)**

(1) <sup>1</sup>The scope of the Bachelor thesis is 12 credits and the working time is ten weeks. <sup>2</sup>The required page or characters number of the Bachelor thesis must be determined in written form by the first supervisor when the topic is being given. <sup>3</sup>As preparation for the Bachelor thesis students are recommended to submit at least one seminar paper during their studies. <sup>4</sup>The basic economic education should be successfully completed by the time of admission to the Bachelor thesis.

(2) The Bachelor thesis shall be written in German or English language.

(3) <sup>1</sup>In case of illness of the student, the working time for the Bachelor thesis may be extended by the examination board upon a request by the student. <sup>2</sup>The request shall be accompanied by an official medical report stating the physical or psychological effects of the illness and its expected duration. <sup>3</sup>The determined length of the extension must be based on this. <sup>4</sup>In the case of illness, where the processing time has already been extended by more than half of the regular processing time by the examination board, the Bachelor thesis can be returned at the request of the student. Sentence 2 applies accordingly.

(4) For degrees that are part of a double degree agreement, the double degree agreement, module catalogue and module description specify whether the Bachelor thesis is to be written at the Europa-Universität Viadrina Frankfurt (Oder) or at the partner university.

(5) For degrees that are part of a double degree agreement, the content of the Bachelor thesis may, in deviation from § 17 (7) sentences 1 and 2 ASPO, be substantially identical with that of a Bachelor thesis formerly or simultaneously submitted by the student to this or the partner university in the context of a double degree agreement, the existence of which is or was a prerequisite for the awarding of an academic degree.

**§ 9**  
**Evaluation of examinations**  
**(Additionally § 23 (1) sentence 3 a), (2)**  
**ASPO)**

<sup>1</sup>The assessment of examinations shall be carried out in accordance with the grades of § 23 (1) sentence 3a) and differentiated in accordance with § 23 (2) ASPO. <sup>2</sup>In the case of modules that are brought in electively, the assessment of examinations can also be carried out according to the grades of § 23 paragraph 1 sentence 3 lit. b).

**§ 10**  
**Compulsory academic consultation**  
**(Additionally, § 1 (2) sentence 2 no. 8, § 3 (3)**  
**sentence 2 and § 6 (1) and (6) ASPO)**

(1) <sup>1</sup>Participation in an academic consultation according to § 6 i. c. w. Section 3 (3) ASPO is obligatory for students in accordance with sections 21 (2) sentence 2 and 20 (3) sentence 1 of the BbgHG if they have not passed the Bachelor examination within ten semesters.

(2) <sup>1</sup>The obligatory academic consultation shall be provided by the head of the responsible examination board. <sup>2</sup>The obligatory academic consultation always takes place in the form of an individual conversation. <sup>3</sup>After receiving a written invitation to the consultation in accordance with §6 (2) ASPO, the conversation usually takes place within four weeks. <sup>4</sup>In order to prepare for this consultation, the head of the responsible examination board may request the faculty's academic advisers for support.

(3) <sup>1</sup>In the event of non-compliance with the concluded study agreement for a valid reason, immediately after becoming known, proof of the valid reason must be provided in written form to the head of the responsible examination board. <sup>2</sup>In the event of illness as a valid reason, this must be proven by an official medical report, in particular in the case of request for resignation from an examination, extension of the working time for home assignments as examination, e.g. seminar papers, as well as extension of the working time for the final thesis. <sup>3</sup>A request for consideration of other valid reasons must be made in written form and accompanied by appropriate supporting evidence. <sup>4</sup>The responsible examination board determines whether there are valid reasons that justify the adjustment of the studies agreement and may authorize the chairperson, if a valid reason is acknowledged, to immediately adjust the study agreement together with the student concerned. <sup>5</sup>If there are no valid reasons acknowledged, the regulations of § 6 (7) sentence 1 ASPO apply.

(4) A template of a study agreement is attached to these regulations as Annex 4.

**§ 11**  
**Commencement / Annulment**

<sup>1</sup>These course-specific regulations come into force on the day after their publication in the official announcements of the European University

Viadrina Frankfurt (Oder) and apply to all students who register for this course of study at the university from the date of entry into force. <sup>2</sup>The course-specific regulations for the International Business Administration (Bachelor) degree program at the European University Viadrina Frankfurt (Oder) dated July 5, 2017, as amended on January 16, 2019, shall expire on March 31, 2025.

**§ 12**  
**Interim regulations**

<sup>1</sup>Students who were already enrolled in the International Business Administration degree program with a Bachelor's degree prior to the entry into force of these program-specific regulations can apply in writing and irrevocably to the Examinations Office until March 31, 2025 for the General Study and Examination Regulations for Bachelor's and Master's degree programs (ASPO) at the European University Viadrina Frankfurt (Oder) dated 27. 01. January 2016, last amended by the Amendment Statute of 2. November 2016, in conjunction with these study program-specific regulations for the study program International Business Administration (Bachelor) in the respective applicable versions will be applied to them. <sup>2</sup>Students in accordance with sentence 1 who have not completed their studies by March 31, 2025, shall be transferred to these study program-specific regulations for the International Business Administration (Bachelor) degree program in conjunction with the General Study and Examination Regulations for Bachelor's and Master's Degree Programs (ASPO) at the European University Viadrina Frankfurt (Oder) dated January 27, 2016, as last amended by the amending statutes of November 2, 2016, in the respective applicable versions.
